#### Walking To and From School Bus Stops

It is the responsibility of parents/guardians to insure their students arrive safely at the assigned bus stop and are ready to load the bus 5 minutes prior to the scheduled pick-up time of the route.

It is recommended that parents/guardians make arrangements to receive students when they are returned to their bus stop at the end of the day.

Parents/guardians and students are encouraged to develop a plan to ensure their student/s arrives safely home at the end of the day.

The safe loading and unloading of students is our main concern. Therefore, students should be cautious with the walking route chosen to get to the school bus stop. Pupils should stay on sidewalks and walking paths while approaching and leaving school bus stops. Students shall wear safe clothing that is visible in hours of darkness.

Go directly to and from the bus stop. Never run to the bus, always walk.	
Plan the safest route with the fewest streets to cross.	
If possible cross streets at corners, using crosswalks if available. Look in all directions before crossing, and when safe, walk across the street. Always obey traffic signals.	
Do not run out in the street from between parked cars or shrubbery.	
Walk to and from school bus stops, out of the roadway facing traffic.	
Never accept a ride from a stranger.	
Leave home early enough so you do not have to run to catch your bus.	

#### School Bus Loading Zone / Boarding Procedures / Bus Stop Rules

Parent reinforcement of these regulations will help considerably in maintaining a high level of safety and a low level of disciplinary problems. Parents/Guardians may be responsible for any damage to vehicles or property caused directly by their students.

Arrive at the bus stop 5 minutes before the scheduled pick up time.	
When waiting for the bus, wait in a safe area.	
 Never play in the street. Never run to the bus, always walk.	
 Do not bring pets or animals to the bus stop.	
Stand in lines or a group facing traffic so you can see the bus approaching. Stand back at least 12 feet from where the bus will stop.	
Vehicles waiting to drop off or pick up students must be parked on the same side of the street as the bus stop. Vehicles must not park where the bus will park.	
When the bus arrives, do not approach the bus until the driver signals that it is safe to do so.

School Bus Loading Zone /Boarding Procedures/Bus Stop Rules Con't
If the student is on the opposite side of the street from the bus stop, the student must wait for the driver to indicate that it is safe to cross, and then cross in front of the bus.
Do not push or shove getting on or off the bus.
When loading at a school, follow the directions of the driver and/school personal on bus duty. Stand back the required 12 feet until the bus driver opens the bus door. Remember, there may be several buses to watch out for, not just your own.
If the student is on the opposite side of the street from the bus stop, the student must wait for the driver to indicate that it is safe to cross, and then cross in front of the bus.
Do not push or shove getting on or off the bus.
When loading at a school, follow the directions of the driver and/or school personal on bus duty. Stand back the required 12 feet until the bus driver opens the bus door. Remember, there may be several buses to watch out for, not just your own.
Destroying property and or any type of horseplay at the bus stop is extremely dangerous and prohibited.
If a student exhibits inappropriate behavior at the bus stop, the driver may issue a write up, which may result in a suspension.

#### **Bus Riding Rules**

In order to ensure the safety of students:

Students will follow all directions of the bus driver.

Students may not bring potentially harmful objects, such as glass, knives or scissors, or animals (other than seeing-eye dogs) onto the bus.

Students may not eat or drink while riding the bus unless given special permission by the bus driver.

Students must keep the aisles clear of books, lunches, feet, etc., and keep the windows and emergency doors closed unless requested to open them by the bus driver. (No part of the student's body may extend outside the window.)

Students will remain seated while the bus is in motion.

Students may talk quietly on the bus. (Shouting is always unacceptable.) For safety measures, students are asked to stop talking at railroad crossings.

No Skate boards or scooters permitted on the school bus.

Students will not engage in actions which jeopardize the rights and/or safety of others or draw attention of the bus driver from the main task of safe operation of the bus, such as:

Fighting on the bus or at the bus stop

Using profanity or obscene gestures

Destruction of property--personal or school

Lighting of matches or lighters

Use of tobacco products

Acts of defiance against the driver's authority or discourtesy

#### **Unloading Procedures**

Students will remain seated until the bus comes to a complete stop and the driver directs them to disembark. Students shall not stand while the bus is in motion.

Students will exit the bus one row at a time beginning with the front of the bus in an orderly manner in compliance with the driver's instructions.

Students will use the handrail at the door and walk down each step to the ground.

After exiting, students should walk away from the bus out of the danger zone, not touch or lean against the bus. Students must not return to or run after the bus. Once again horse play is prohibited.


Students shall not cross the street upon which the bus is parked without assistance from the driver. If crossing, let driver know at the stop. Follow all instructions given by the driver when crossing the street.

Students' parents/guardians must be present, waiting on the same side of the street as the bus stop. A student requiring to be met by a parent or guardian that is not present and the transportation department is not able to make contact the student will be returned to the school.

Escort stop only - let your driver be the first one off. Once the driver is off you may exit and stand by the side of the bus. When the driver is in the middle of the street and directs you to do so, cross the street between the driver and the front of the bus.

#### School Bus Danger Zone

Each student must be aware of the area surrounding the school bus called the Danger Zone. The Danger Zone is the area extending twelve feet in all directions from the school bus in which serious student injury and death can occur. Students need to follow the directions of the bus driver and stay away from the danger zone areas. Students exiting the bus should remain in clear view of the bus driver after they exit.

#### **Procedures for Temporary Bus Stop Changes**

Student shall utilize their designated stop only, unless they have a note from their parent or guardian. Prior to boarding the bus, the student must take the note to the school office and have school administration verify the note. The driver will then show the verified note to the driver when boarding the bus. Students without proper authorization will be returned to the school.

#### Must Be Met Policy (Special Education & Kindergarten Students Only)

All Special Ed students must be met by an adult at the drop off bus unless arrangements have been established with the Transportation Department.

All other students, 1st -12th grades, are self-release except for kindergarten students.

Kindergarten students must be met by an adult.

Self-release students are expected to know their own way home.

If the student must be met by an adult and the designated person is not at the bus stop to meet the bus, the student will be returned to the school.

#### Passenger Restraint Systems

When a school bus or student activity bus is equipped with a passenger restrain system, all passengers shall be required to be properly restrained by that system while the bus is in motion.
